CONDITIONS OF SERVICE:

- In an effort to improve our efficiency and prevent launch delays, please return this checklist by March 31, 2016.
- In order for work to be started we must have a signed, completed Spring Commissioning Checklist. Request for work will generally be assigned on a first come-first serve basis. The spring season is always a very busy time and we can only launch a limited number of boats per week.
- Shop Labor rate is \$109.00 per hour. Road Work Labor rate is \$119.00 per hour. Time is based on actual time the technician is dispatched from the office until he reports the work completed.
- Keys or a combination must be available in the office or on the boat prior to spring commissioning.
- Fenders and dock lines must be left on board or a delay in launch may result.
- All batteries must be on board prior to spring commissioning.
- No boat will be launched until the area around the boat is clean and clear of debris.
- The owner shall be responsible for the vessel's safety and have insurance coverage for the vessel while in the yard.
- The owner acknowledges that the yard makes no representation regarding the adequacy of water levels at time of launch.
- **NO OUTSIDE LABOR** or independent contractor is allowed unless prior permission is obtained from the yard office. The yard reserves the right to: require proof of adequate liability insurance and hold the owner responsible for the activities of the contractor and other signing in and out requirements.
- The owner agrees to adhere to all State and Federal rules and laws and will be responsible for misuse.
- The yard provides no security protection and assumes no responsibility for person or property.
- Overboard discharge of heads or holding tanks within the yard is strictly prohibited
- **BEWARE- THE VESSEL AND ITS CONTENTS MAY BE SOLD AT AUCTION FOR FAILURE TO PAY STORAGE CHARGES.**
- **ACCRUED WINTER CHARGES MUST BE PAID PRIOR TO SPRING COMMISSIONING WORK BEING DONE.**
- **SPRING COMMISSIONING CHARGES ARE DUE WHEN RENDERED. A 1.5% SERVICE CHARGE PER MONTH (18% ANNUALLY) WILL BE ADDED TO BALANCES PAST 30 DAYS DUE AND THE CUSTOMER WILL BE RESPONSIBLE FOR ALL COLLECTION EXPENSES.**
