BID PROCEDURES

1. Bids are closed on Monday at 3:00 pm Eastern Time. The high bid on each vessel is submitted to the Seller (i.e. Bank, Government Agency or Owner) on Tuesday morning. The Seller, at its sole option, may accept or reject the bid or make a counter bid. Responses typically occur within 48 hours.
2. All vessels/RV are sold AS IS WHERE IS, with no warranties, express or implied, as to condition or fitness for a particular purpose.
3. A credit card number must accompany any bid submitted. Upon acceptance of a bid, \$1,000 will be charged to the credit card. If the credit card is declined the bid will immediately be voided. Gross bids over 75000 USD will require a ten percent (10%) deposit via wire transfer upon acceptance.
4. Upon verbal notification of acceptance of a bid, buyer has 5 working days to complete any "conditions" as set forth and pay the amount due IN FULL via certified funds. Failure to close the transaction within 5 business days after notice of acceptance will result in \$1000 deposit to be forfeited and the boat/RV placed back into the next auction cycle.
5. Bidder has 24 hours (or one business day) to remove the purchased vessel/RV from our facility or make storage arrangements after closing. Storage charges will accrue on ALL vessels/RV until vessel/RV departs at our standard rates (refer to <http://www.usliquidators.com> for current storage guidelines).

NOTICE TO CUSTOMERS REGARDING TITLING OR DOCUMENTATION

We exert extensive time and research to ensure that you are purchasing a unit with a clear title or USCG documentation. The \$399.00 administrative fee represents this research effort; it does not include transferring title or documentation. Buyers will receive from our title department all the documentation needed to complete this process. We can provide complete transfer of title or USCG documentation for an additional fee. Please contact our offices and ask to speak with our title department if interested.

IMPORTANT INFORMATION REGARDING SALES TAX

All purchasers will either pay sales tax at the current approved rate in their respective states or sign an out-of-state affidavit that they will pay their respective sales tax and provide a valid copy of a driver's license (with the exception Florida residents who must pay tax directly to us at point of sale). All dealers will be required to provide a state sales tax number, valid dealer's certificate and sign a resale certificate or Statement for Exemption of Purchase. RV purchases will have sales tax collected on all transactions (unless we are provided a dealer exemption certificate) up to the maximum of six percent and sign an affidavit for partial exemption.

METHODS OF PAYMENT

By certified funds, financing or bank wire. No drafts, personal or company checks or credit cards accepted (aside from initial deposit).
