AQUAPALOOZA RELEASE AND WAIVER OF LIABILITY

1. Release of all Liability (including negligence).

I AGREE TO FULLY RELEASE AND DISCHARGE RUSSELL MARINE LLC, SEA RAY, A DIVISION OF BRUNSWICK, AND DOCKS UNLIMITED LLC, FROM ANY LIABILITY for any damages, injuries, or claims, loss or theft of property, including any injuries or damages occurring from any negligence of Russell Marine LLC, Sea Ray, a division of Brunswick and Docks Unlimited LLC (collectively referred to as "Released Parties"), its members, managers, officers, employees and agents, to myself or any other person or property, as a result my use of the mooring facilities and any other facilities located at the Aquapalooza event (the "Aquapalooza Facilities") on Lake Martin, Alabama. I fully understand and agree to release Released Parties, its members, managers, officers, employees and agents, for any negligence in causing in whole or in part any injury to me or any person for whom I am responsible under this Agreement and for any theft or other loss of personal property while I am or my boat is on the site of Aquapalooza Facilities.

2. Agreement Not to Sue and Indemnification.

I hereby waive, release, and forever discharge for myself, my heirs, executors, administrators, legal representatives, (including successors), any and all rights and/or claims which I have, may have, or may hereafter accrue to me, and agree not to sue or file any claims of whatever nature against Released Parties for any and all damages, personal property losses, injuries or claims which may be sustained by me directly or indirectly arising out of my use of the Aquapalooza Facilities.

I hereby agree to indemnify and hold the Released Parties harmless from any and all rights, causes of actions, disputes, liabilities, and claims, including claims arising from Released Parties' negligence, which I have or which may hereafter accrue to me, together with any and all damages, including but not limited to my property or my person, which may be sustained by me directly or indirectly in connection with, or arising out of, my use of the Aquapalooza Facilities or any activities incidental thereto wherever or however the same may occur.

3. I (parent or guardian for persons under 18 years of age) represent and warrant that I possess sufficient skills and competence to negotiate any and all conditions that may be encountered during the proposed use of Aquapalooza Facilities and acknowledge that I have inspected the Aquapalooza Facilities and that the Aquapalooza Facilities are maintained in a safe operating condition. I certify that my boat is equipped to moor safely in connection with the Aquapalooza Facilities.

4. I realize that use of the Aquapalooza Facilities may require physical strength and conditioning and I represent that I am in sound medical condition. I have no physical or medical impairment which would endanger me or others. I understand and agree that a situation may arise while using the Aquapalooza Facilities that may be beyond the control of Released Parties and agree to use the Aquapalooza Facilities so as not to endanger myself or others.

5. The above agreements and representations are my express understandings of the risks and I assume these voluntarily and freely without coercion or duress. This Agreement may not be modified orally and may not be waived in any respect. I accept responsibility for the condition and adequacy of the Aquapalooza Facilities, and agree to abide by the rules of Released Parties related to the use of the Aquapalooza Facilities as well as other organizational requirements. I am aware of the risks of the risks of using the Aquapalooza Facilities and voluntarily assume such risks.

6. I agree that if any portion of this Agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect and that the laws of the State of Alabama will apply.
