1. LIABILITY RELEASE. 2. COVENANT NOT TO SUE AND WAIVER OF SUBROGATION. I further agree that I will never sue Frankie's Marine et al for damages on account of injury, death or damage I suffer or cause whether known now or which may develop in the future. In the event Frankie's Marine et al sued because of my actions, I understand that I am waiving my rights to sue Frankie's Marine and Full et al I am also waiving my rights of recovery from Frankie's Marine et al I am waiving my rights of recovery from Frankie's Marine et al of my insurance carrier for any claims they may pay on my behalf. This includes all their employees.

3. VERIFICATION OF LIABILITY INSURANCE. I maintain a minimum of \$100,000 liability insurance on the boat I will use in this tournament.
