(INITIAL \_\_\_) I understand and am aware that Wakeboarding/Wakeskating/Tubes/Wake Surfboards is an inherently dangerous activity, this danger includes harm to me including death. I understand that the sport of Wakeboarding/Wakeskating/ Tubing/Wake Surfing and the use of Wakeboarding/Wakeskating/ Tubing/Wake Surfing equipment involves a risk of injury to any and all parts of my body. I agree to freely and expressly assume and accept any and all risks of injury or death to me while using this Wakeboarding/Wakeskating/ Tubing/Wake Surfing equipment or while taking a lesson.

(INITIAL \_\_\_) I understand that the Wakeboarding/Wakeskating/ Tubing/Wake Surfing equipment being furnished includes a binding system which will NOT RELEASE at all times or under all circumstances, and that it is not possible to predict every situation in which it will or will not release, and that its' use cannot guarantee my safety or freedom from injury or death while using the Wakeboarding/Wakeskating/ Tubing/Wake Surfing equipment.

(INITIAL \_\_\_) I agree that I will release Seattle Boat Co. (Supreme Northwest, Inc.), and the owners and operators of any boat used for lessons from any and all responsibility for injuries or damages to me due to the use of Wakeboarding/Wakeskating/ Tubing/Wake Surfing equipment or the participation in taking lessons in Wakeboarding/Wakeskating/ Tubing/Wake Surfing.

(INITIAL \_\_\_) I will not & I instruct heirs of my estate to NOT to make claim, legal or otherwise, against Seattle Boat Co. (Supreme Northwest, Inc.), and the owners and operators or managers of this event for any accident or damage incurred as a result of any boat used for lessons or demonstration rides or any way in which I freely request to participate in. In addition I hold Supreme Northwest, its owners, managers & employees harmless of all acts associated with this event.

(INITIAL \_\_\_) I understand and am aware that while the driver owners and operators of any boat used for lessons or demonstration rides will drive to the best of their ability & not all environments remain static and outside influences can affect the ride, boat performance, or driver's ability to operate the boat. I freely accept this risk as a danger in participating in this event.

This Document constitutes the final and entire agreement between the persons and companies released by this Agreement and the undersigned. I have carefully read this agreement and release of liability and fully understand

its contents. I am aware that this is a release of liability and an agreement for the benefit of Seattle Boat Co. (Supreme Northwest, Inc.), owners and operators of boats used for lessons and/or demonstration rides and I sign of my own free will. I hereby assume any and all responsibility for bodily injury, death, property damage and/or litigation that may occur as a result of my participation.
